Conversion from the Good to the Better

As we enter the season of Lent I am reminded of one of the Franciscan Values Guiding FAN developed by Fr. Tom Nairn, OFM, which states: "Franciscan vision is transformational, demanding change and conversion in its adherents, following the example of Saints Francis and Clare. Francis saw his entire life as a continuing conversion into the vision of God, whom he saw as a loving parent. Francis saw his life as a continuous conversion from sin to a life lived in gratitude for God's love. Many described the conversion of Clare from 'the good to the better.' The Franciscan life today remains one of on-going conversion. There is always an unfinished quality to this conversion until we enter into the Reign of God."

Our readings this <u>first Sunday of Lent</u> remind us that continuing conversion occurs only with total dependence on God. The psalmist cries out, "Be with



me, Lord, when I am in trouble." (Ps. 91: 15b) while St. Paul assures us in the letter to the Romans, "for everyone who calls on the name of the Lord will be saved." (Rom. 10:13) In our Gospel, St. Mark recounts the temptations of Jesus in the desert by Satan. With each attempt by Satan, Jesus goes "into the vision of God," to the word of God to find strength to overcome each temptation. Every time we are tempted to be complacent when we are confronted with injustice, tempted to exert power over those more vulnerable than ourselves, or tempted to pursue "more" for ourselves at the expense of others, our baptismal mandate calls us to "continuous conversion from sin to a life lived in gratitude for God's love."

As we pursue our 2019 Lenten journey let us strive to follow the example of St. Clare of Assisi, for continuous conversion from "the good to the better."

This Wednesday, March 6th the House Judiciary Committee will hold hearings on the human impacts of terminating important programs like DACA, Temporary Protected Status (TPS) designations, and Liberian Deferred Enforced Departure (DED). These programs were a promise to protect people from deportation and family separation. It is critical that people of faith stand in solidarity with our immigrant neighbors and call for the introduction and passage of a permanent legislative solution.



As March 6th is also Ash Wednesday, join us for a <u>National Call-In Day</u> as we begin this holy season of Lent. Together, let us urge our Members of Congress to pass a permanent legislative solution with a pathway to citizenship for all.

Here is a sample script:

Hello, my name is [NAME] from [CITY, STATE] and as a person of faith, I support dreamers, Temporary Protected Status holders and Liberian Deferred Enforced Departure (DED) holders. I am calling to ask you to take a stand against the unjust terminations of these protections. Sign and Share: Stop Plastic Pollution Petition

Plastic production is directly connected to climate change as 99% of plastics are derived from fossil fuels. U.S. shorelines are littered with millions of tons of single-use plastic. We must cut down our reliance on single-use plastics. While this can seem like a daunting task, we invite you to take a simple action as part of your commitment to Living the Change.



Start with something small, like <u>plastic straws</u>. It's estimated that 1 billion plastic straws are used daily worldwide. Single-use plastic straws are not recycled. They are used for minutes and become instant plastic pollution, many times ending up in our oceans. However, several major U.S. cities, including Seattle and Washington, D.C., have limited single-use plastic straws. Let's build on this momentum.

<u>Sign the petition</u> to call on your local elected officials to limit plastic straws and make straws available only upon request. When possible, you will be connected to local organizers working on a campaign near you.

Good News on Gun Violence Prevention: HR8 and HR1112 Pass the House

Last week, the House of Representatives passed two bills aimed at cutting back gun violence. The first was <u>H.R. 8</u>, the bi-partisan bill to expand Brady background checks. Democrats <u>called</u> the 240-190 vote a major step to end the gun lobby's grip on Washington.

The second bill was <u>H.R. 1112</u>, the *Enhanced Background Checks Act of 2019*. This bill will address the so-called "Charleston Loophole" and minimize the risk of gun sales proceeding before a background check is completed by extending the



time granted to law enforcement to complete a background check from three to ten business days.

It's very encouraging to see movement on these important measures. After 25 years of stagnation in Congress, last year's massacre at Marjory Stoneman Douglas high in Florida prompted this new wave of student-led activism that gives us tremendous hope.
