On <u>this Sunday</u> when we celebrate our Trinitarian God we are reminded that, as human beings made in the image and likeness of our God, we are interconnected with all of God's creation. Human beings are social in nature. The interpersonal relationship of the Trinitarian God reveals to us that all creation is interdependent on, and connected to, each other. Our news media is replete with examples of how an injustice to one part of God's creation affects us all.



In *Laudato Si* Pope Francis, referring to the teachings of the Franciscan Saint Bonaventure stated: "the world, created according to the divine model, is a web of relationships. Creatures tend towards God, and in turn it is proper to every living being to tend towards other things, so that throughout the universe we can find any number of constant and secretly interwoven relationships." *Laudato Si 240*

The Trinity teaches us about community and belonging. The Trinity challenges individualism and self-serving behavior. The Trinity challenges all walls and borders that divide us. We are not a collection of independent individuals. We need each other and paradoxically, the more we think in terms of "we" vs "me" the more truly we are who we are created to be as an individual.

Pope Francis again refers to St. Bonaventure when he states: our interconnectedness "leads us not only to marvel at the manifold connections existing among creatures, but also to discover a key to our own fulfilment. The human person grows more, matures more and is sanctified more to the extent that he or she enters into relationships, going out from themselves to live in communion with God, with others and with all creatures." *Laudato Si 240*

With Pope Francis, may we pray to "develop a spirituality of global solidarity which flows from the mystery of the Trinity".

This proposed rule is deeply concerning as it seeks to prevent mixed status families

Victory: House Passes American Dream and Promise

Act of 2019

This past week, the House of Representatives passed H.R. 6, better known as the American Dream and Promise Act of 2019. The bill provides a pathway for DREAMers, TPS holders, and DED recipients to attain their green cards if they meet certain requirements and also cancels removal proceedings against them. This bipartisan legislation gives all



immigrants hope in a time where their status is caught in a legal limbo in our immigration system.

The measure passed 237-187 on the strength of Democratic support with seven Republican ayes. Don Bacon, NE-2; Mario Diaz-Balart FL-25; Brian Fitzpatrick, PA-1; Will Hurd, TX-23; Dan Newhouse, WA-4; Christopher H. Smith, NJ-4; and Fred Upton, MI-6. Please look up how your member voted here and **if your member voted AYE**, please call and say thanks. The Franciscan Action Network <u>applauded</u> the move in this statement released June 5th.

We have refocused our energies on building support for the bill in the Senate, which will be a significant task. We can't do it without you.
