### Where Is My Treasure?

Faith without fear is a strong theme in <u>this week's</u> <u>readings</u>. Abraham, Sarah, and many generations are held up as models who "did not receive what had been promised but saw it from afar and acknowledged themselves to be strangers and aliens on earth..." And "All died in faith." Today, as this country and the world struggles with a migration crisis, it is good for us to remind ourselves that we are all migrants, all sojourners, in our time on Earth. As we sojourn, a critical question



for each of us is "What do I treasure?" Critical because Jesus teaches "Where your treasure is, there also will your heart be." That is, your purpose in life, what gives you meaning and happiness.

We have myriad examples of people who knew where their treasure was and allowed it to direct their hearts. Clare of Assisi, whose feast is August 11th, is a shining example of one who knew at a young age where her treasure was and gave herself wholeheartedly to living it with faith, not receiving papal approval for her Rule of Life until she was dying.

It is not hard to find examples today. An elderly neighbor spends every moment caring for her beloved husband who is sinking deeper into Alzheimer's. Parents of a mentally disabled young woman surround her with love, support, and opportunities, with unrelenting patience. Catholics deeply concerned about the inhumane conditions in which immigrant children are held in detention <u>gather</u> in the nation's capital to pray and call for the administration to stop the inhumanity. Seventy women and men, religious and lay, are arrested in an act of nonviolent civil disobedience. A young mother writes an <u>inspiring article</u> explaining why she brought her 3 year old son to join the Catholic Action.

These are some of my experiences of people whose hearts compel them to do what they do because they know where their treasure lies. I suggest that the treasure is even more than a husband, a daughter, or immigrant children. God's presence in their hearts guides them to do the right, true, loving thing. You have examples of your own. Include yourself. Be encouraged with Jesus' promise: "Do not be afraid... for your Father is pleased to give you the kingdom."

## Another Tragic Shooting Spurs Petitions and PSA's

In the wake of yet another tragic shooting -this time at a community festival in Gilroy, California -- the pattern of shock, mourning, anger, and despair feels like déjà vu. As we try to make sense, yet again, of the stagnancy of our government, an email from a group called SumOfUs came across my inbox. say <u>NO</u> to #WeaponsOfWar.



<u>SumOfUs</u> is a global advocacy organization and online community that campaigns to hold large corporations accountable on

multiple issues, including gun violence. Their email contained an <u>article from the New York</u> <u>Times</u> which outlines how big banks and credit card companies could effectively confront this issue even when Washington won't

With a rallying cry to find some "good in the world", the folks at SumOfUs have developed a <u>petition</u> urging Visa to do their part to help curb gun violence by reporting excessive, erratic gun and ammo purchases to law enforcement. If you've ever gotten a fraud alert from your credit card then you already know how easy it is for credit card companies to spot and investigate suspicious activity. **We urge our members and friends to** <u>take action and sign</u> <u>the petition</u>.

Additionally, we want to let you know about a new organization called <u>Our Next 4 Years</u>. Our Next 4 Years is staffed by over 300 volunteer animation professionals (Oscar and Emmy winners and nominees among them) who have banded together to create animated public service announcements "countering the regressive policies of the current administration." They have created <u>this video</u> urging a federal ban on weapons of war. FAN institutional members the <u>Sisters of St. Francis of Philadelphia</u> were a sponsor of the project. We urge you to watch and share it in your networks and on social media.

## **Rise for Refuge Actions Fight Against Zero**

## **Admissions Reports**

Last month, <u>reports surfaced</u> that a refugee admissions ceiling of **zero** is being considered for fiscal year 2020.

Eliminating refugee resettlement to the U.S., despite facing the largest displacement crisis in global history, would be immoral and completely opposite of our beliefs as well as having grave, long-term implications for the future. Lowering the refugee admissions ceiling any further than the 2019 historic low of 30,000 is unacceptable.

# Done with Detention Campaign Would Freeze Growth of Detention Camps

Coinciding with the reintroduction of the <u>Detention Oversight Not Expansion</u> (DONE) Act by Sen. Kamala Harris (D-CA) and Rep. Pramila Jayapal (D-WA), Freedom for Immigrants launched last week an <u>interactive map of</u> <u>U.S. immigration detention</u> as part of the new Done with Detention Campaign. The map highlights history of expansion, ICE contracts, bond statistics and more. We encourage you to educate yourself and others using these resources.



Additionally, United We Dream has been asking allies to hold vigils and protests outside Immigration Customs Enforcement (ICE) office nationwide. We learned last week that <u>multiple</u> <u>Jewish organizations</u> have partnered to coordinate an effort Jewish vigils and protests to take place on their holiday of <u>Tisha B'Av</u> (August 10-11, 2019), demanding an end to immigrant dehumanization. Similar to our Catholic day of Action, the Tisha B'Av events are billed as a public demonstration "that the Jewish community will not turn its back on refugees arriving in our country and our immigrant neighbors already here." # Columban Center Launches Campaign Calling for a 100% Clean Energy Economy

This June, Pope Francis declared that the



world is in a "climate emergency."

In answer to this declaration, the <u>Columban Center for Advocacy</u> has launched a campaign which is a pledge to advocate for a 100% clean energy economy. They are asking people of faith to meet with their Members of Congress during the August recess to urge them to support a federal response to climate change that puts the US on a path towards a 100% clean energy economy by 2050.

### **Tell Congress to Declare a Climate Emergency Now**

Announced by several Congressional leaders, the declaration expresses the sense of



Congress that climate change is a national emergency and demands an "economically just and managed phase-out of oil, gas and coal to keep fossil fuels in the ground" as part of a "national, social, industrial, and economic mobilization of the resources and labor of the United States at a massive-scale to halt, reverse, mitigate and prepare for the consequences of the climate emergency and to restore the climate for future generations." The resolution has since gained the support of every major presidential candidate in the Senate and over 35 members of the House.

There is no more time for multi-decade solutions or small steps forward. If we don't act now, Earth could become uninhabitable in a matter of decades.
