#### **How Can We Co-Create Our World?**

This week's readings can be among the most challenging of Jesus' teachings. "Who can know God's counsel, or who can conceive what the Lord intends." (Wis. 9:13) After the mass killings in Texas and Ohio several weeks ago, a travel advisory to the United States was issued warning people throughout the world that it is no longer safe to visit this country we call home.

Meanwhile, as we begin a new school year, parents and children worry about violence in our schools. Our government continues to



separate children from their parents and to imprison many of these children in deplorable detention centers. Our readings confront us to determine what it means for us to authentically live from our Catholic Social Tradition and follow in the footsteps of Jesus in this world.

The rich tradition handed down to us by Saints Francis and Clare of Assisi of professing our faith, not so much by beliefs or recitation of pious words but by the way we live our lives, orients our life of continuous conversion. In the words of the FAN <u>vision statement</u>: "It is through continual conversion that the cry of the earth and the cry of the poor can be heard in their authenticity and understood in a way that leads us to re-discover our original goodness, both personally and collectively. Through this process of continual conversion, we discover ourselves as co-creators with God and others."

How are we to co-create our world? When we look to Jesus' years of public ministry, we see that Jesus advocated for and reached out to the most vulnerable in His society, always with an eye and heart turned to His Father. Our commitment to follow Jesus will be at times inconvenient, when we must "carry our cross." (LK 14:26) Our commitment to follow Jesus will always force us out of our comfort zone. May God "Teach us to number our days aright, that we may gain wisdom of heart." (PS 90:12)



### Weekly Prayer and Action in Support of Immigrant Children

Thank you for your continuing support of the DC Catholic Coalition <u>Campaign</u> to end child detention, and the traumatizing abuse of migrant children. It is imperative that we continue this work on behalf of those whose lives depend on our action – the children and families in detention. The Trump administration has announced it will use a new immigration rule that would allow it to detain some immigrant children and families indefinitely, replacing the 1997 Flores settlement, which had limited the length of time children could be held in detention, because detention is so harmful to children.

# This Week's St. Clare Pledge Ask: Ask your Rep to Sponsor the Democracy For All Amendment

The Gospel of Matthew tells us that we must not serve God and money. (Matthew 6:24) This message is hard to hear in our government today.

With the *Citizens United* decision nine years ago, the Supreme Court opened the floodgates for unlimited corporate money to pour into our politics and corrupt our democracy. Americans overwhelmingly want to overturn this



decision with a constitutional amendment. A **call-in day to Congress on Thursday**, **September 5th** has been coordinated by good governance partners to encourage more co-sponsors on H.J. Res. 2, the House resolution version of the amendment.

To make our democracy work and ensure our government responds to the will of the people, rather than the mega-donors, we must overturn *Citizens United*. **Call your Representative at 202-224-3121 and ask that she/he cosponsors the Democracy For All constitutional amendment to overturn** *Citizens United***. Be sure to let us know how it went.**


Attendees will learn about existing protections for these children, residential care options, influx facilities, as well as ways to get involved.

### Join an Action and Support Federal Funding to Secure our Votes

Without a paper trail, our voting system is extremely vulnerable to hacking and foul play. The entire national security community agrees that election interference is a genuine threat unless Congress acts. Yet, the Senate has failed to move forward with critical election security funding for states.

Right now, due to popular outcry, there is a chance to win funding in the next Congressional appropriations bill to secure our elections by replacing election machines with paper ballots. **On September 17th**, a nationwide day of

### **Center for Migration Studies Offers Resources**

The <u>Center for Migration Studies</u> (CMS) of New York is a think tank and educational institute devoted to the study of international migration and has developed a series of initiatives to uplift and strengthen the work of Catholic



institutions that respond to the needs of migrants, refugees, and newcomers.

Here are some of the services that CMS provides Catholic institutions

- Published <u>summaries</u> of successful Catholic programs, campaigns and practices on immigrant protection and integration
- <u>Migration Update</u>, a weekly digest of news, faith, reflections and analysis of migration and refugee protection. Our weekly digest also provides migration policy and research updates. The Policy Update section is now available in Spanish.
- Detailed and geographically precise estimates on <u>undocumented and</u> <u>eligible-to-naturalize residents</u> in the United States. This data can allow programs, organizations, and parishes to understand the composition of their immigrant communities and tailor their work accordingly.
- Publications including The Effects of Immigration Enforcement on Faith-Based
   Organizations: An Analysis of the FEER Survey which analyzes how U.S
   immigration policies impact the work of Catholic institutions, programs and ministries
   that serve immigrant and refugee populations.
- <u>Reports</u> based on rigorous investigation and fieldwork. In 2017, CMS partnered Kino Border Initiative and the Office of Justice and Ecology of the Jesuit Conference of Canada and the United States and released <u>Communities in Crisis</u>: <u>Removals and Their Human Consequences</u> which examines the characteristics of deportees and the effects of deportation.
