### Are We a Stiff-Necked People?

This <u>Sunday's readings</u> are familiar to us: the First Reading tells of the Golden Calf where God tells Moses, "I see how stiff-necked this people is," (Ex: 32:9) and the Gospel is a variety of parables of which we are all very familiar, including the Prodigal Son and the Lost Sheep.

When reflecting on these readings, I stumbled across a cartoon from David Hayward, who goes by the moniker "<u>Naked Pastor</u>".

When I saw it, I immediately thought to myself how "stiff necked" the 99 sheep were! When we hear the parable



of the Lost Sheep, we often think only of the one sheep that was lost, not the other 99 who may have been acting stubborn, just as when hearing of the Prodigal Son, we only focus on the "lost" brother, not the other brother. We might also actually view the 99 sheep as just that—sheep rather than as an analogy for human beings who reject others. In fact, the 99 were the lost ones, just as the "faithful" brother in the Prodigal Son had some shortcomings of his own. (Anger and jealousy for starters.) Both the 99 sheep and the "other brother" were "stiff necked" just as the Israelites in the Old Testament who decided to worship the Golden Calf instead of God. The Israelites were so "stiff necked" that they didn't even realize that they were going through a crisis of faith and disobeying God. Like the 99 sheep and the "other brother" they were so certain of themselves that they were doing the right thing. But were they?

When Jesus tells these parables, he's addressing the Pharisees, which today has become a synonym for self-righteous hypocrites as they were so obsessed with following the letter of the law, they believed themselves to be better than everyone else. The Pharisees too were "stiff-necked" and did not understand Jesus' message—they accuse him at the start of the Gospel of welcoming and eating with sinners. (Lk: 15:2) But who was really sinning by turning themselves away from God?

As we enter this week and continue to reflect on the readings, let's ask ourselves: are we too so "stiff necked" that we turn away from God and worship our own golden calves of materialism, self-centeredness, and false prophets? Are we following Jesus by welcoming and eating with sinners? Or are we Pharisees who reject the lost sheep and the Prodigal Son and judge others who are different from us?

Do we even welcome and eat with our own neighbors let alone those we might silently judge as "sinners"? Today our neighborhoods, communities, and churches seem so divided. Are we welcoming our immigrant sisters and brothers? Are we breaking bread with our LGBTQ sisters and brothers? Our Muslim sisters and brothers? Those who have different political viewpoints? Or are we so "stiff-necked" that we reject them like the Lost Sheep or Prodigal Son and don't realize that in fact we are the ones that turned away from God and sinned?

I've been in the D.C. area for 11 years and have worked at FAN for almost six. In this time I have encountered many who believe that they have all the answers, that others should listen to them, that they are in fact the "Chosen One." We know this to be false. At a time when we are so divided, we need to turn to God and work together using our "both feet" of faith and action to solve the great challenges of our time and welcome those some have deemed "the other" and we must be wary of false prophets and Golden Calves.

## Successful Catholic Action in Newark Supports an End to Immigrant Detention

The Franciscan family was well-represented at last week's <u>Catholic Action for Immigrant</u> <u>Children</u> that took place in Newark, NJ with over 20 sisters, brothers, and seculars in attendance. (See photo) The event saw over 400 people come together to protest the detention of children and separation of families.

The Catholic Coalition chose Newark as its first follow up event because many from that



region who came to the <u>DC action in July</u> expressed energy for a national action in their area. There has also been over 20 years of activism of Catholics in and around New Jersey to advocate for and minister to immigrants and their families who have been targeted by ICE for detention and deportation. Local groups have been working to pressure local politicians to end all detention and improve conditions in the interim.

The Essex County Jail was recently <u>in the news over conditions</u> for immigrant detainees that DHS itself said were not only unsafe, unsanitary and inhumane, they were among the worst in the country. New Jersey is home to three other detention centers, the Hudson and Bergen County Jails and the Elizabeth Detention Center which have also been plagued by poor conditions and avoidable deaths.

Cardinal Joseph W. Tobin, C.Ss.R., Archbishop of Newark gave a blessing to those participating, saying, "We stand together in prayer and solidarity with our immigrant sisters and brothers. When they suffer, we suffer, the Church suffers, the Body of Christ suffers. We are one in the Lord and share in the very suffering of Christ."

Second, they will discontinue sales of several types of *ammunition* as well as discontinue selling handguns in Alaska. While this is good news, Walmart is one of the country's largest gun retailers and we feel they can and should do more. 

Finally, it is <u>known</u> that the shooter who killed 7 people and wounded 25 others in West Texas last weekend should not have been able to purchase his firearm and would have failed a background check. But he exploited a loophole in our federal law...precisely the kind of loophole the Senate can close by taking action and passing a bill requiring background checks on all gun sales. For this week's <u>St. Clare Pledge</u>, we encourage all our members and friends to make a <u>call to your Senator</u> and urge him/her to support background checks on all gun sales.

## Join an Action and Support Federal Funding to Secure our Votes

Without a paper trail, our voting system is extremely vulnerable to hacking and foul play. The entire national security community agrees that election interference is a genuine threat unless Congress acts. Yet, the Senate has failed to move forward with critical election security funding for states.

Right now, due to popular outcry, there is a chance to win funding in the next Congressional appropriations bill to secure our elections by replacing election machines with paper ballots. **On September 17th, a nationwide day of**

Under the current law, more than 40 states choose to provide SNAP to families with more savings than otherwise allowed by SNAP rules, and to allow SNAP benefits to working households with somewhat higher income but with significant expenses for shelter and child care. This current policy option is known as "Broad-Based Categorical Eligibility" (or "Cat El"). The Trump Administration is proposing to eliminate these options for states. If enacted, this would eliminate SNAP benefits for 3.1 million individuals and take free school meals away from 500,000 children in those families.

FAN has joined the Coalition on Human Needs and other partners in coordinating an effort to gain as many comments about this proposal as we can. We must make it clear that these cuts would harm struggling people. Please <u>take action and make a comment</u> here. **The 60-day comment period ends September 23rd.** 

## **Register to Ring Bells in a Franciscan Call for Peace**
