### Who is on Our Doorstep?

In reading this Sunday's Gospel about the rich man and Lazarus I was reminded of another story I read about a man who, when going to his office everyday, noticed a ragged looking child sitting outside the building begging. This irritated the man who asked God everyday why God did not do something about this. One day he heard God's answer: "I did do something, I created you!"



I do not know if this man acted on God's message or not. We do know that the rich man in the Gospel was enjoying his wealth and paid no attention to those suffering and perhaps did not even know that Lazarus was on his doorstep.

Are we aware of who is on our doorstep? Or do we see them and act like we didn't, and really wish we hadn't seen those suffering? We need to also heed the caution that Amos gave the chosen people in the First Reading. Amos cautioned the people against a false sense of security. That if they think God expects nothing more of them because they are the chosen people, they are mistaken and this complacency can lead to ruin.

That is exactly what happened to the rich man for when he died he was sent to the "netherworld where he was tormented". Lazarus died at the same time but was taken by the "angels to the bosom of Abraham". When the rich man begged Father Abraham to warn his five brothers, Abraham answered: "They have Moses and the prophets, let them listen to them."

Who or what has God placed in our path to warn us – the beatitudes, the commandments, the Social Justice Principles, modern day prophets, and those suffering - God places these in our path to warn us to notice injustices. We are challenged by the reality that it is hard to be giving in a society where having is deemed more important.

# Take Action: Sign Petition urging Senate to Act on Climate Change

The Catholic Climate Covenant has launched a campaign during the Season of Creation which FAN has joined on as a participant. By providing opportunities designed to inspire Catholics who may have never before expressed concern about climate change, we hope to create an unprecedented collaborative effort across the US Catholic community to generate a resounding Catholic call to climate action that Congress and American society will hear.



To that end, we urge all our members and friends to <u>sign this petition</u> calling on the Senate to act on climate change. Once you've signed, **please share the petition with others.** Your faith voice is needed to uplift our shared moral responsibility to care for our common home.

### Take Action: Make a Call for Refugee Resettlement

Last week, the administration held a meeting to discuss plans for the refugee admissions goal for Fiscal Year 2020, with some officials previously proposing resettling zero refugees next year. This would decimate the bipartisan refugee resettlement program and follows FY 2019's historically low goal of 30,000.

The administration has already been



dismantling the refugee resettlement program and is <u>considering</u> granting authority to states and localities to deny refugee resettlement in their communities, undermining U.S. law and violating our nation's commitment to welcome the most vulnerable refugees. **As people of faith who care about refugees, we must call for a robust refugee admissions goal** of 95,000 in FY20 and prepare for a rapid response as soon as we hear how many refugees the administration plans to welcome in FY 2020.

By law, the administration must consult with Congress by the end of September, prior to setting the refugee admissions goal, which means it is critical our elected officials hear from us. ## Poor People's Campaign Kicks off "We Must Do M.O.R.E." Tour

The Poor People's Campaign: A National Call for Moral Revival announced last week a 9-Month, 22-State tour called "We Must Do M.O.R.E." The tour kicked off in El Paso, TX September 16-18 and will continue to stop at various cities until May of 2020. The goal of the tour is to demand the implementation of the campaign's Moral Agenda and call all people of conscience to engage in deeply moral civic engagement and voting that cares about people, the environment, and peace.



#### From their website:

Rather than through the limited framework of left or right, we will draw on our deepest constitutional, religious and moral values to challenge both political parties to address an economy that isn't working for most of us. Systemic racism is dangerously impacting our democracy from voter suppression to denial of immigrant and indigenous rights. The reality of 140 million people who are poor or low-wealth and just one \$400 emergency away from being poor — and who represent every race, color, creed, religion, sexual orientation, and political party and account for 43.5% of the people living in the richest nation in the world — is a moral crisis.

# Take Action: Contact your Representative and Urge a Vote on No Ban Act

Last week, the House of Representatives announced an historic hearing on the Muslim Ban will take place tomorrow, Sept. 24th. This will be the first ever hearing on the Muslim Ban and a first step toward a House vote on the NO BAN



Act (<u>H.R. 2214/S. 1123</u>). While FAN staff and Muslim advocates pack the hearing room tomorrow, we need you to <u>make your voice heard</u>.

Since the Muslim Ban was first enacted, discrimination against American Muslims has skyrocketed while countless families remain separated, missing out on births, funerals, weddings and even necessary medical care. Congress has the power to end the Muslim Ban by passing the NO BAN Act.

As a second <u>St. Clare Pledge commitment</u>, we urge all our members and friends to <u>contact your Representatives</u> and tell them to pass the No Ban Act. America was founded on principles of religious freedom for all. We must end this discrimination against our Muslim sisters and brothers.
