It's very hard for you and I, or anyone of this time and age, to accept a Miracle. We all love to hear about a Miracle but when it comes down to it, we are more like "doubting Thomas" then we are someone like Blessed Solanus Casey (a Capuchin) who not only relied on a Miracle but expected one. Our power of logic and reason tilts us toward the need to provide proof. In fact even the Church has rules that rely on proof of an act of God



(Miracles) before the Church says it was a Miracle.

Please, I am not saying that trying to prove God's intervention or action is bad. It just seems to be part of our nature to look at everything else before we accept that God has done a great thing. But at the same time, I have to admit that it tends to be part of our nature to blame bad things on God not doing something. I am speaking to our questioning why would God allow something or cause something that is horrible.

The Miracle in this week's Gospel echoes these beliefs. Many thought the blind man was faking it so that he could eat and live without working for what he needs daily. Why does this part of the story sound so much like some of our discussions when it comes to helping others with food, or programs to assist them onto a level playing field?

Solanus Casey on the other hand encourages us all to expect God to work and move in our lives. In fact his life challenged us to thank God ahead of time! To expect God to answer our needs and our prayers.

So, today we are challenged and are given a choice.

Will we be like the Pharisees of old and let the letter of the law rule and use that to *not* embrace, to pray and *not* take action, to *not* feed the hungry, to *not* work for justice? Or will we be like Blessed Solanus Casey, thanking God for His work in our midst *by what we do* personally to those who are on the margins of our society?

# FAN Delivers 150,000 Signatures to Congress in Support of No Ban Act

Last week, FAN was proud to be present at the delivery of more than 150,000 signatures to the office of Rep. Judy Chu (pictured) calling for the House to pass the National Origin-Based Antidiscrimination for Nonimmigrants Act. Also known as the NO BAN Act (H.R. 2214), the legislation would amend the Immigration and Nationality Act (INA) to prohibit discrimination on the basis of religion and eliminate the Trump administration's ongoing travel ban.



The House was supposed to vote on the NO

BAN Act last Thursday, but needed to temporarily delay the vote to pass an emergency stimulus package to address the coronavirus epidemic.

While this is disappointing, we are keeping up the pressure on our elected officials. We need to make it clear that the House must pass this important bill upon their return from recess this week. If you haven't already, please, add your name and share this petition far and wide.

# Democracy for All Amendment Call-in Day March 19th

Pope Francis calls on each of us to "meddle in politics" and we interpret this concept as a requirement that all Americans must have an



equal say in the public square. However, working against this ideal is the impact of big money.

The corrosive influence of big money in politics impacts all of us. It prevents our voices from being heard and incentivizes elected officials to respond to political donors over everyday people. The influence of big money in politics has become so severe that a **constitutional amendment** has become the only recourse for addressing this existential threat to the health of our democracy.

The Democracy For All amendment (H.J. Res. 2) is the leading amendment proposal to get big money out of our political system and it already has 214 Co-Sponsors in the House of Representatives. **This Thursday, March 19th is a <u>call-in day</u>** focusing on those Representatives who have not yet co-sponsored the Amendment. **Join us in calling on your Representative to support the Democracy For All Amendment**.

We must confront corruption, and put the power of our democracy back in the hands of the American people. <u>Urge your Representative to support the Democracy For All Amendment.</u>
