Overcoming of Self to Be Like Sheep

According to many critics, egoism is especially an American vice. Supposedly, our culture is one all about celebrating the self. We hold up as a hero the purportedly self-made woman or man who is "in"-dependent, by which we mean that she or he is free from depending on anyone or anything else. We glorify the idea of the radical individual, whom we describe without irony as lifting himself up by his own bootstraps. Our national myth (much abetted by Hollywood) is that our country's uniqueness



comes from the grit of rugged individuals winning greatness by their own gumption and hard work.

<u>This week's readings</u> remind us, however, that to follow Christ requires a different attitude. For Christians, greatness is not about the ego. Christ calls us to overcome the self. Indeed, if these readings are taken literally, then we are to be like sheep.

Friedrich Nietzsche – whom we all know for his notion that God is dead – despised Christian morality precisely because of how it diminishes the self. In books like *The Genealogy of Morals* and *The Birth of Tragedy*, Nietzsche lampooned Scripture passages like this one where Christians are compared to sheep. True morality, he thought, was found only in being true to our own self will, in being autonomous – in being a law only unto oneself. Be the wolf that eats the sheep, Nietzsche thought, or at least be the shepherd, but how despicable merely to be one of the sheep!

Yet, as Christians that is our calling.

Overcoming the self is not a one-off reference in Scripture, but at the very heart of the Gospel message. We're told to humble ourselves so as to be like children. That one who exalts herself shall be humbled and that the humbled will be exalted. That the meek shall inherit the earth. And, most profoundly, that "Whoever wants to be my disciple must deny themselves and take up their cross and follow me." (Mk 8:27) Today's reading from the letter of Peter notes that even Christ sacrificed his human will to "hand himself over" to the divine will.

Which brings things back to the situation in America... Because, maybe our country is not as much about celebrating the self as some think.

Look around. We wear those masks in public. We avoid congregating with our friends. We social distance and give up travel. Yes, we do such things in part out of fear of catching the disease ourselves. But, isn't it even more true that we do such things for others, especially for those most vulnerable to the disease, and for the common good of the whole country? Think

about the overcoming of self that it takes for those who serve in public now – the nurses, the grocery store clerks, those who deliver the mail, and those who pick up our garbage.

At one of the demonstrations against social distancing recently, ugly voices were heard shouting at hospital workers coming off a shift. The shouts called the medical workers "sheep" for wearing masks.

Sheep.

"I am the good shepherd, says the Lord; I know my sheep, and mine know me." Alleluia.

Franciscans Celebrate Mother Earth Day Nationwide

Credited with launching the environmental movement, 20 million people took part in the first Earth Day in 1970. Since then, many landmark environmental laws and regulations were passed in rapid succession as the movement gained momentum over the next several decades.

Last week, we took time to rekindle our hope and renew our commitment for climate justice. After our virtual Franciscan EAD gathering on Friday, we shared several possible actions for people to



take, including <u>sending a letter to your member of Congress</u> to require the EPA to cease the complete dismantling of protections in place to care for our common home.

During Pandemic FAN Continues to Advocate for Immigration Reform

Last week the U.S. Conference of Catholic Bishops released a daily Rosary for Vulnerable People on the



<u>Move</u>. This Rosary will provide reflections on various vulnerable migrant populations, directions on how to pray the Rosary, and text for each of the prayers.

FAN was one of 224 faith-based organizations and over 1,000 faith leaders who signed on to a <u>letter</u> sent to the Trump administration, Congress, and Governors, telling them that "immigrants, refugees, and asylum seekers must be included in our emergency response [to COVID-19] if we are to assist everyone who is in need." Additionally, FAN's director of Campaigns and Development, Jason Miller appeared in this <u>EWTN story</u>.


In response to the President's announcement last week of a temporary ban on immigration, FAN issued this statement calling on the administration to stop using the coronavirus pandemic as cover for immoral and un-American policies. Articles in America Magazine, the Christian Post and the Hartford Courant contained quotes from the statement.

As we continue to <u>anticipate</u> a Supreme Court decision on the termination of the DACA program, we are encouraged by the news that the Court granted a <u>motion</u> to consider the supplemental circumstances created by the coronavirus and some additional information as they consider the case. The next potential date for a decision is today, April 27th.

Because of the corona-virus pandemic, our election schedule has already been thrown way off course. Primaries held during the outbreak have risked voters' health and many states have postponed them in the interest of public safety. Here are several good steps towards securing other



protections for our elections.

In the interest of preserving public health *and* voting rights, FAN has joined other good governance groups in a petition that all states pass <u>no-excuse absentee voting</u>. The best way to protect all human beings is to maintain social distancing. State officials can help accomplish this by minimizing obstacles to casting ballots from the safety of homes and shelters. Call to Action: Save the Postal Service

As a trusted faith-based organization, FAN was contacted by the Democracy Initiative about a unified campaign to secure emergency federal funds to support the Postal Service which has been hit hard by the COVID-19 pandemic and recession. Some facts about the current state of our postal system:

- Due to the COVID-19 pandemic, mail revenues are down by at least 30%, creating a grave and rapidly deteriorating financial situation for the USPS and more than 600,000 postal workers.
- The Post Office is an essential frontline service delivering social security checks, tax refunds, absentee ballots, and now COVID-19 stimulus checks to hundreds of millions of Americans.
- During the 2020 Elections, when we need to massively expand voting by mail to
 ensure voters do not have to choose between their health and having a say in our
 democracy, the USPS has never been more essential.
