#### A choice to make

As I reflect on the readings for this <u>3rd Sunday of Easter</u>, I am struck by the contrasts between the first reading from Acts and John's Gospel. Both readings speak of an order given but with a different response.

In the reading from Acts the apostles disobey the order given to them by the Sanhedrin "to stop teaching in that name," meaning Jesus of Nazareth, and continue to do so even at the peril of their own lives. In fact they boldly proclaim: "We must obey God rather than men."



In the Gospel the apostles also receive a command: "Cast the net over the right side of the boat and you will find something," and in spite of being tired from a night of fishing and catching nothing, not knowing the One who was giving them the order/suggestion, or protesting that they knew what they were doing, they obeyed and were rewarded with 153 large fish and breakfast.

What is the lesson for me/us in these two moments in Scripture?

Often we too are confronted with a choice, should I do it or not? Should I say it or not? The apostles in Acts were sure of their choice. They were preaching Jesus of Nazareth. They all lived a profound experience with Jesus and were ready to give up their lives to tell others about it. The experience of being with Jesus gave them the strength and the joy of even being thought "fools," and "they went away rejoicing that they had been found worthy to suffer dishonor for the sake of the name." What kind of experience of Jesus am I living? Do I have the same conviction that speaking about Him and His teaching is an urgent need for me? Do I speak of the values of the Gospel when they are welcomed and when they are not? In our secularized and violent world do I have the courage to spread a message of love, welcome and mercy?

The event in John's Gospel is one of my favorites - and not just because of breakfast! The apostles must have sensed when the man told them to lower the nets that this was not an ordinary encounter; in fact, they followed his instruction without resistance. I can think of many instances in my life when I followed an inspiration, a strong prompting from within, without really knowing why, just knowing that it was the right thing to do and only after the fact came to know why it was the right call. The answer came soon for the apostles. They caught many fish, and it took a simple nudge from John to Peter, "It is the Lord," to open their eyes, that it could only be Jesus. A frustrating night chosen to escape sadness turned into a beautiful breakfast on the beach with the person they loved and missed so much.

I pray that we too do not miss our inspirations. In this time of Easter when talking about and witnessing to the Resurrection is what it is all about, may we not miss the occasion to do so out of our fear and doubt. May the presence of Jesus alive in our midst give us the inspiration to go

the extra mile to proclaim what we believe, that God is still present in this world, that power and money will not overtake the power of love and justice. How beautiful it would be to be able to say with our whole heart: "Lord you know everything, you know that I love you."

Give us the capacity to even for a moment taste the richness of the feast you give us.


Give us the peace to live with uncertainty, with questions, with doubts.

# Amid Pushback on Ending Title 42, Take Action for Asylum

On April 1, 2022, the Biden administration announced that, effective May 23, it will end a Trump-era expulsion policy, known as Title 42, that for over two years has prevented people seeking refuge from danger or persecution from exercising their legal right to apply for asylum at the Southwest border.

Now, a group of Democrat and Republican lawmakers is trying to stop the Biden administration from ending Title 42, citing fears of an overwhelmed border system due to increases in arrivals of migrants at the border.

The introduction of two new bills, one in the House and one in the Senate, aimed at preventing the end to Title 42 call us to action.
