

### **Jesus Keeps His Promise**

The Easter story is not complete without Pentecost which we will celebrate this weekend. For just a few years, Jesus was on Earth physically. He taught, healed, suffered, died, rose from the dead, hung around with his friends for 40 days, and ascended into the heavens. But he did not leave us to fend for ourselves. He gave us Eucharist to nourish us and **promised** to send the Holy Spirit to inspire, challenge, and comfort us. On that first Pentecost the disciples gathered

They threw open the doors and spoke to the diverse multitude "in different tongues, as the Spirit enabled them to proclaim."

On Pentecost 2022 we could make a long list of daunting challenges we face locally, nationally, globally, in society and in the Church. It is tempting to huddle together in fear and lock the doors as the first disciples did. Do we have the desire to cry "Come, Holy Spirit!"? Come and renew the face of the Earth; renew our country; renew the Church; renew me, because renewal today depends on how we, how I, collaborate with the Spirit. Come as a strong wind, or as a breath, or as fire. Be our Advocate, and enable us to be advocates with and for your suffering people and suffering Earth. May June 18<sup>th</sup> be a Pentecost moment as thousands of advocates meet in Washington, DC or gather locally or virtually, to participate in the Poor People's Campaign moral march to demand justice, compassion, inclusion for all God's people and protection for God's sacred creation.

## **Work on Asylum Protection Continues**

On May 20, a U.S. District Court in Lafayette, Louisiana issued a preliminary injunction preventing the CDC from ending Title 42 on May 23 as planned. The Justice Department rightfully filed a swift appeal and the Department of Homeland Security (DHS) has indicated it will continue to plan for the lifting of Title 42 while the appeal proceeds.



Disappointed as we are, we continue to work

toward a welcoming society. We hosted an <u>issue briefing and exchange</u> last week where we heard from Franciscans working at the border who shared the genuine struggles of real people seeking comfort in our country. This <u>Messaging Guidance</u> document is from our friends at Welcome with Dignity. It is lengthy but worth reading for a deep understanding of the issue. It walks you through the background and current status of the legislation along with general talking points and resources.

This is a pivotal moment in our fight to end Title 42 and restore asylum and we urge you to take action by calling on President Biden and Congress to halt inhumane expulsions and reject anti-asylum policies at the border. Thank you!

## **Another Mass Shooting Bolsters Gun Violence Prevention Efforts**

This week, we are heartbroken and weary from another mass shooting, this time at Robb Elementary School in Uvalde, TX, so soon after the shooting at a supermarket in Buffalo. The frustration at a lack of governmental action is palpable within our offices and homes. Read our statement here.

## **Climate Can't Wait: Take Action Today**

Climate change is devastating Earth's life support systems, harming our communities, and putting future generations at risk. We must continue to call on our elected officials to prioritize the climate in policies to ensure a livable future for us all, especially for those in vulnerable and underserved communities.

Members of Congress often tell us that messages from constituents do make a difference. Today, we offer several actions to take:

- Food & Water Watch urges us to tell the Army Corps to stop fast-track authorization of dangerous fossil fuel pipelines.
- Interfaith Power and Light urges us tell the Securities and Exchange Commission that investors deserve to know about climate risks.
- <u>EarthJustice</u> urges us to tell the Army Corps to revoke and not reissue the wetlands destruction permit for the PolyMet mine in Minnesota.

In addition to these very specific actions, we encourage you to continue to <u>contact your</u> <u>members of Congress</u> and call on them to **support the \$555 billion in climate provisions of the <u>budget reconciliation bill</u>** that will protect our world and secure a more just and prosperous future for all people.



# Efforts to Reconcile and Heal with Indigenous Peoples

The U.S. Department of Interior recently released Volume 1 of an investigative report called for as part of the Federal Indian Boarding School Initiative, a comprehensive effort to address the troubled legacy of federal Indian boarding school policies. This is a significant step by the federal government to comprehensively address the facts and consequences



of its federal Indian boarding school policies. The report presents the opportunity for the U.S. government to reorient federal policies to support the revitalization of Tribal languages and cultural practices.

No corporation or organization should profit from or facilitate sexual exploitation. Yet, unfortunately, many well-established brands, companies, and organizations profit as significant contributors to sexual exploitation.

The Dirty Dozen List is an annual campaign of the <u>National Center on Sexual Exploitation</u> (NCOSE) calling out twelve mainstream entities for facilitating or profiting from sexual abuse and



exploitation. The <u>May edition of the Stop Trafficking Newsletter</u> highlights the 12 corporations or organizations which are the focus of this year's Dirty Dozen List. Included in the "Action" section of the newsletter are numerous ways you may add your Franciscan voice to those advocating for change.
