In the Vineyard of the Lord

In Sunday's readings for the 27th Sunday in Ordinary Time, there is much talk of vineyards. In our day and age, many of us have very little to do with vineyards. And yet, we still eat the fruits and vegetables that grow in those vineyards. The landowner in the gospel needed his vineyard tended, so he leased it to tenants who he thought were trustworthy. When it came time to obtain his produce, the landowner was met with violence and the death of his servants, and eventually his own son.

Where can we interject ourselves into this story? How can we think of it in terms of our lives today? One of the images that came to mind for me was the words of preparation of the gifts during the Mass, when the chalice is elevated: "Blessed are you, Lord God of all creation, for through your goodness we have received the wine we offer you: fruit of the vine and work of human hands; it will become our spiritual drink." Hearing those words, I know that someone had to work that vineyard in order for that wine to make it to the altar of our Lord. We hear those words so often, yet do we really think about the actual work of the human hands that it took to create what will become our spiritual drink?

The landowner in the gospel knew the importance of having trustworthy tenants tend his vineyard. He knew that eventually the vineyard would yield a bountiful harvest; a harvest that would earn for him and his family the wealth they needed to live. For us today, we pray that the work of human hands will flourish so that we may have a harvest to feast upon. And who are those "human hands"? Well, these days they are the migrants, the day laborers, and those who are mostly on the margins of society, yet are greatly needed to gather the harvest.

Do we think about those migrants who sweat and toil in the hot sun to bring in a harvest so that we can have fresh fruits and vegetables? They are easy to overlook when we are not the ones out in the hot sun picking strawberries for pennies. Can we imagine those people whose hands are parched from picking fruit? Do we even think about that as we go to the grocery store and pick out the fruit that someone else had to harvest? The next time you buy fruits and vegetables, and eat those fruits and vegetables, say a prayer for those migrants whose "human hands" helped get them to your table.

Again, it is sometimes difficult to imagine these parables in our own context, but Jesus told these parables for a reason. It was not just for the people of his day, but for all of us, for all time. Those parables are timeless, and their meanings touch our lives to this day. As we go about our comfortable lives, we can reimagine those timeless and meaningful stories our Lord Jesus

shared with us. Doing so can not only deepen our prayer life, but also open our hearts and minds.

Check out the work of the Franciscan Action Network including the complex issues of immigration. There is much to learn and much more to do.

That we may act for just laws and policies for our migrant brothers and sisters, we pray...

Prayer:

God of love and compassion, may we always recognize your spirit:

in the refugee family, seeking safety from violence;

in the migrant worker, bringing food to our tables;

in the asylum-seekers, seeking justice for their families;

in the unaccompanied child, traveling in a dangerous world.

Give us hearts that break open whenever our brothers and sisters turn to us.

Give us hearts that no longer turn deaf to their voices in times of need.

Give us eyes to recognize a moment for grace instead of a threat.

Give us voices that fail to remain silent but which decide instead to advocate prophetically.


Give us hands that reach out in welcome, but also in work, for a world of justice until all homelands are safe and secure.


The Global Days of Action for Peace in Ukraine are going on this week. Plans have been made
