Reflection Date: January 12, 2025 - The Baptism of the Lord

Baptized for this (un)Ordinary Time

I don't remember my baptism. For many "cradle Catholics," it was a choice made by our good parents, not by us, and we were carried to church as infants. This baptismal choice was confirmed in the sacrament of confirmation, but I was 11 years old, so it was still not a fully understood choice. Later, when I witnessed the baptism of adults, I was almost envious. Theirs was an informed, deliberate choice to follow the teachings of Jesus Christ as a member of the



Christian community. My clear commitment to my baptismal promises came later.

The sacrament of baptism is not as much about being washed of our sins as it is about emergence into the new life of the risen Christ by joining the Christian community. On this great feast of the Baptism of the Lord, the word "sin" is mentioned only once in the Scriptures of the Liturgy Year C. In <u>Isaiah 40</u>, God says, "Give comfort to my people"; Jerusalem "has received from the hand of the Lord, double for all her sins." In Year A, Isaiah 42, the word "sin" is not mentioned at all.

If baptism were only about cleansing from sin, there would be no need for Jesus to be baptized. Jesus CHOSE to be baptized by John to fulfill John's teaching that the Christ would baptize "with the Holy Spirit and fire." Upon this understanding of his mission, the heavens opened, the Holy Spirit came upon him in the form of a dove, and God's voice affirmed, "You are my beloved Son; with you I am well pleased."

Francis of Assisi was given the name "John" when he was baptized, but because he was so attracted by chivalry and French "chansons," his father called him "Frenchie," Francis. We know that Francis' commitment to fulfill his baptismal promise to follow in the footprints of Jesus Christ took a journey of several years. But once made, he never wavered. Certainly, God was "well pleased" with God's beloved son, Francis.

This feast also concludes the wondrous Christmas Season, and tomorrow we enter liturgically into "Ordinary Time." Given all the challenges that face us in 2025, time does not seem "ordinary." In our personal, social, and communal lives, with deep divisions in politics—both national and global—and even in the Church, we feel that the time is "unordinary." This is a time to reflect on our own baptismal commitment to follow in the footprints of Jesus Christ, not only as individuals but also as members of the Christian community. Are there ways in which each of us can become more engaged with FAN, with Catholic Social teaching, in our parishes and congregations? Do you believe that you are a beloved daughter or son of God?


Father in Heaven,


