# **Learning Faith Through Loving Witness**

For Día de los Muertos, at the time of writing this reflection, I'm gathering old pictures of family members who have passed on. Their black-and-white photos mingle with the scraggly, free marigolds I picked up on my way to work at the Monastery. I'm lighting candles and thinking especially of those I've lost. The reading from the Book of Wisdom (Wisdom 3:1-9) for the Feast of All Souls reminds us that their souls are in God's care, beyond suffering, "proved as gold in the furnace" and taken into peace.

When I prayed over the readings for All Souls, I was reminded of my great-grandmother Evelyn. When she was in the hospital, we read Psalm 23 to her, reminding ourselves that God is always with us, even in the scariest of times. My great-grandmother was a strong, loving person—a potato farmer who found joy in small things like operating a tractor; mom to nine kids and someone who gave the best hugs. Most of all, she was deeply faith-filled. She loved the earth, loved the land, and worked for justice each day of her life. She made the world more beautiful, called for the dignity of immigrants and for peace, and made her small town in Wisconsin a more loving place. She taught me about faith not by telling me what to do, but by living it fully.



God's love, poured into our hearts through Christ, continues even through struggle and loss. My great grandmother's life reminds me that living faithfully means caring for creation, standing with the marginalized, and working for peace and justice. This is the same spirit that guides the work of the Franciscan Action Network: acting out of love and mercy, even when change is slow. Our work for justice shines in the world, guided by God's will.

As I reflect on these readings and my own traditions, I am inspired to honor the people who have shaped and touched my life, and to let their example guide my faith and actions. Día de los Muertos and All Souls Day is a time to remember those who have inspired us and consider how we can carry forward their love, courage, and commitment to justice in our own lives.

# Take Action to Protect our National Forests

After Secretary of Agriculture Brooke Rollins cancelled the **Roadless Rule**—a 2001 regulation that protects 45 million acres of National Forest from road construction—members of the U.S. House and Senate have proposed legislation to reinstate the rule.

Please consider asking your representatives in Congress to support these bills, which are essential to protect our National Forests and the precious and irreplaceable wildlife, water sources, Native American sacred places, and recreational opportunities they contain. Allowing road construction is likely to lead to logging and mineral extraction.



## **Imminent SNAP Cuts Put Families at Risk**



Amidst the government shutdown, all SNAP (Supplemental Nutrition Assistance Program) benefits, which provide low-income families with vital access to food and nutrition, will be paused starting on Saturday, November 1. If states choose to continue providing funding, the US

Department of Agriculture will not issue reimbursements.

This was announced despite the explicit statement in the USDA's 2025 Lapse of Funding Plan that in the event of an extended shutdown, SNAP operations should continue. You can act <a href="here">here</a>, encouraging the USDA to deploy contingency funding. We are proud to collaborate with MAZON: A Jewish Response to Hunger on this critical issue.


## **Continue Conference Advocacy Today**

Please ask Congress to act with urgency, after returning from this prolonged shutdown, to advance the Renewing Immigration Provisions bills (S. 2468/

H.R. 4696) out of the Judiciary Committees in the House and Senate for a vote.





## Israel/Palestine


Despite the recent ceasefire, Gaza is far from being on a path to a sustainable and just peace. Since taking office, the present Administration has continued the pattern of recent Administrations and approved a series of arms sales to Israel totaling over \$12.5 billion. Independent investigations have found that U.S. weapons have been used in unlawful attacks that killed dozens of Palestinian civilians, including children.



Please join FAN in urging the House of Representative to advance the Block the Bombs Act, H.R. 3565, introduced by Representative Delia Ramirez (IL-3), which would prohibit the President from selling, transferring, or exporting certain defense articles or services, including heavy bombs, to Israel except in specified circumstances.
