# When Is Righteous Anger the Right Response?

We seldom hear of Jesus being angry, as we do in the <u>gospel reading for Sunday, November 9</u> (John 2:13-22). Perhaps that is why most Christians see anger as simply a negative emotion. However, when that powerful energy is properly controlled and directed, it can be a source of justice and even holiness.

Let's be clear, though: righteous anger is not the same as normal anger. It cannot be directed for personal gain or toward another person. It is anger against the spiritual powers that thrive on injustice and attacks on the worth of human beings and the rest of God's creation.

When it comes to actual righteous anger, I would go so far as to say that NOT being angry is sometimes a sin. Thomas Aquinas suggested precisely this, arguing that he who is not angry when there is just cause for anger is immoral. Why? Because anger looks to the good of justice. And if you can live amid injustice without anger, you are immoral as well as unjust.

Martin Luther King Jr. makes the same point even more harshly: "The hottest place in Hell is reserved for those who remain neutral in times of great moral conflict." He explained that the person "who accepts evil without protesting against it is really cooperating with it."

So how can you know when and how to feel and express righteous anger? Pray. Pray. And again I say: Pray.

It is so very hard not to give in to an anger which is actually full of self-righteousness. Wait. Wait. And again I say: Wait. The destructive anger coming from self is coming from your emotions—and is often short-lived. Be sure that your goal is always healing, as Christ healed. Christ heals not only the body, but also the soul.

When you have prayed and waited, and the righteous anger remains and shows itself to be genuine—it is time for action. It is time to turn that anger into constructive action to protect the vulnerable and advance the flourishing of all. Through FAN, we can collectively come together and express that anger through protests, advocacy, and countless other ways. And we can again pray—that our righteous anger may advance justice.



## Franciscans COP30 Message

Please join Franciscans around the world in praying for ecological conversion as the world gathers at COP30, the global environmental summit, in Belem, Brazil, November 10-17. The General Ministers of the Order of Friars Minor, OFM Conv, OFM Cap, TOR, and Secular Franciscan Order issued a joint call October 28 for "a lifelong journey of conversion of mind, heart, and action, recognizing the dignity and sanctity of all of life, and our responsibility to care for one another and for our Sister, Mother Earth." As Franciscans prepare to gather in Belem on November 14 for a special event commemorating St. Francis' Canticle, the Ministers prayed: "May world leaders recognize the urgency of what is at stake and commit to concrete.

### **Continue to Take Action**

#### Immigration:

Please ask Congress to act with urgency, after returning from this prolonged shutdown, to advance the Renewing Immigration Provisions bills (S. 2468/H.R. 4696) out of the Judiciary Committees in the House and Senate for a vote.

This bill would create a streamlined path to citizenship for DACA recipients, TPS holders, farmworkers, and undocumented essential workers by amending the Immigration and National



Act (INA) which governs the "registry" process (a path to legal status for certain long-term residents). If passed, the bill would update the registry process, giving long-term residents who have lived in the U.S. for at least seven years an opportunity to apply for legal status.

#### Israel/Palestine

Despite the recent ceasefire, Gaza is far from being on a path to a sustainable and just peace. Since taking office, the present Administration has continued the pattern of recent Administrations and approved a series of arms sales to Israel totaling over \$12.5 billion. Independent investigations have found that U.S. weapons have been used in unlawful attacks that killed dozens of Palestinian civilians, including children.

Please join FAN in urging the House of Representative to advance the Block the Bombs Act, H.R. 3565, introduced by Representative Delia Ramirez (IL-3), which would prohibit the President from selling, transferring, or exporting certain defense articles or services, including heavy bombs, to Israel except in specified circumstances.

**Care for Creation:** 

After Secretary of Agriculture Brooke Rollins cancelled the **Roadless Rule**—a 2001 regulation that protects 45 million acres of National Forest from road construction—members of the U.S. House and Senate have proposed legislation to reinstate the rule.

Please consider asking your representatives in Congress to support these bills, which are essential to protect our National Forests and the precious and irreplaceable wildlife, water sources, Native American sacred places, and recreational opportunities they contain. Allowing road construction is likely to lead to logging and mineral extraction.
