“I Did Not Know Him”

In the gospel reading for the [Second Sunday in Ordinary Time](#), when John the Baptist turns the attention of the crowd toward Jesus, he says twice: “I did not know him.” Certainly, John knew his cousin as a relative. We were first introduced to John when he leaped in Elizabeth’s womb as Mary, pregnant with Jesus, greeted John’s mom. It is likely, though not told in Scripture, that Jesus and John knew each other as they grew and matured into manhood. But it is only when John saw the Spirit descend on his cousin that he fully realized who Jesus was: Son of God, Messiah.



Francis of Assisi, raised a Christian, knew *about* Jesus. He was familiar with his story, but he did not truly *know* Jesus until the Crucified One spoke to him and gave him a mission. From then on, Francis grew in his knowledge of Jesus Christ, and desired nothing more than to *identify* with the Christ he loved with all his mind, heart, and soul.

As a vowed Franciscan woman, I am grateful for our Third Order Regular charism of “continuous conversion.” Francis’ conversion took time. Every day I am invited to be converted, transformed into the person God wants me to be. John’s acknowledgement of not fully knowing Jesus challenges me to ask myself how well I know other people. How well do I know my friends, my family, my sisters in community, my co-workers? How well do I know people with

whom I disagree? Those whom I dislike? How well do I know myself? How well do I know the Jesus I follow, God Creator, God Holy Spirit?

I will never fully know God in this life. The more I think I know, the less I know God, Great Mystery. But the wonderful truth is, God knows me. God knows my puny attempts to know the Divine; knows my virtues and good intentions; knows my faults and my failures—and loves all of me, unconditionally. God knows you and loves you unconditionally.

In his First Letter, John the Evangelist writes: “Whoever says ‘I know him,’ but does not keep his commandments is a liar . . . whoever claims to abide in him ought to walk just as he walked.” This is the invitation of Jesus Christ to me, to you, to walk in his footprints. Sometimes his footprints are clear and strong, sometimes faint, sometimes bloody. But if we want to know him, we must walk in his footprints.

As part of the Franciscan Action Network, this is what we are called to do. Rather than simply proclaiming our faithfulness, we are called to demonstrate it by following Christ’s footsteps to the margins, where we can join together to protect the vulnerable, defend the earth, and engage in creative nonviolence.


Mourning and Action in Wake of ICE Shooting

As Franciscans, we grieve the killing of Renee Nicole Good, a woman shot and killed by an ICE officer in Minneapolis, Minnesota last week. We pray for her family, friends, and the Minnesota community. We are called to stand with our immigrant brothers and sisters, as well as with U.S. citizens who advocate for their rights. We urge a full and transparent investigation and accountability for officers involved so tragedies like this are not repeated in the future.



Please consider taking action with FAN by calling on Congress to exercise discernment in voting for additional funding in the FY2026 Homeland Security Appropriations Bill. This bill would expand ICE's enforcement and removal operations, including more funding for officers who carry out interior raids, transportation and removal of people, and hiring additional enforcement personnel. Affirming Conscience Protections for Members of the U.S. Military

In a speech last Friday, January 9, Pope Leo XIV [said](#), "At this moment in history, freedom of conscience seems increasingly to be questioned by States, even those that claim to be based on democracy and human rights." In the United States, on November 19, Senators Mark Kelly and Elissa Slotkin, and Representatives Jason Crow, Chris Deluzio, Maggie Goodlander, and Chrissy Houlahan released a video reminding members of the U.S. armed forces of their obligation to refuse illegal orders. The Trump Administration responded with verbal attacks and punitive actions.
